### Requirements for Admission

The following is required of applicants who wish to become candidates for a degree at Finger Lakes Community College:

- 1. Submission of a complete Finger Lakes Community College Application for Admission. A Finger Lakes Community Collegepplication form is preferred; however, the State University of New York College Application form is also accepted. Applicationfee may be charged.
- 2. Students are required to adhere to the College's Immunization Policy. Students in selected programs and studentathletes may be required to submit additional health and immunization documentation.
- 3. Students lacking prerequisites for entry into their program of interest may be advised to take courses designed toprepare them for course work in their chosen major.

5. The deadline for studentto matriculate into the College for the fall semester is November 1. The deadline for the springsemester is March 1.

#### **Admission Process**

- 1. Applicants must complete an online Finger Lakes Community College application form and request that official highschool and college transcripts be mailed to the Admissions Office.
  - a. Current high school students applying for admission upon graduation should download the high school counselofform from the online application and forward it to their high school guidance counselor for completion. The highthool counselor is responsible for completing the form and returning it with the student's high school transcript the Admissions Office. The applicant is responsible for forwarding a final, official high school transcript to Admissions Office once his/her graduation has been recorded.
  - b. High school graduates must include an official high school transcript from an accredited high school with their application.
